Required documents for a new water service application

1. Compliance certificate. (This may be obtained from MEPA after submitting an “Architect’s Declaration for the Issue of a Compliance Certificate”. **Important: This certificate is valid for 4 weeks from date of issue.**)
2. Site plan. (Available from the architect or MEPA.)
3. Colour Photo (6”x4”) of facade of premises where service is required.
4. Payment: Lm70 (house, villa, garage, office, maisonette, boathouse, showroom, restroom, etc)
Lm35 (flat, common entrance of flats)

Consumers sending their application by post must attach a photocopy of their I.D. card.
